## ASX Announcement 11 February 2009

MPS has invited Mr Philip Bruce, Managing Director of Hill End Gold Limited to give an investor presentation on their recent field operations and their immediate mining company goals.

Barry Dawes has recently conducted a number of client briefings on the importance of having good gold stocks in your portfolio. MPS has been supporter of Hill End Gold for over 5 years now and we are delighted with the progress the company is making and invite our clients for an update on their important activities.

Hill End Gold Limited has commenced small scale gold production from the very high grade Hill End Project in NSW. Previous production from the Hawkins Hill workings was at a grade of ten ounces per tonne and recent production using modern methods has been of the order of one ounce per tonne.

Resources in the newly opened Reward Gold are 160,000 tonnes at 17g/t. Mining beneath the old workings has confirmed the high grade continuity of the rich Paxton's ore zone and is about to open up the high grade and wide Frenchman's zone. Gravity gold recovery of over 95% has been achieved and processing at a rate of approximately 80 tonnes per day has commenced. The project has further upside with the large Hargraves deposit at Big Nugget Hill, which has been outlined by drilling over 500 metres along strike and to a depth of 400 metres, and has a target scope of 10mt at 4g/t.

The Hill End Project is beginning to realise the potential of the rich, under-explored Hill End Anticline.

Following many enquiries from shareholders and investors, HEG is refining a portion of its gold to produce 99.99% Hill End Gold' one ounce investment bars which will be made available in coming weeks.
