**Investa Property Group
Equity Raising Completed**

A successful equity raising yesterday of \$90.9 million by Investa Property Group, will enable the Group to fund various initiatives. The bookbuild was underwritten by UBS Warburg and Deutsche Bank.

Investa announced its intention to the market yesterday, and after strong demand for the issue we are pleased to announce that the equity raising has now been finalised, with a total of 45,000,000 stapled securities to be issued at \$2.02 per security.

Accordingly we request a lifting of the trading halt for the commencement of trade this morning.

Existing IPG securityholders will be able to apply for securities at the same issue price of \$2.02 per security pursuant to a Security Holder Purchase Plan ('SPP'). Full details of the SPP will be dispatched to securityholders shortly.
