# INVESTA PROPERTY GROUP Leasing Update

Investa Properties Limited as the responsible entity for Investa Property Trust is pleased to announce the successful execution of approximately 17,300m² of new leases, renewals and extensions. Chris OʻDonnell, Managing Director, said, "The announcement of these leasing transactions demonstrates the continued focus of the Group on maximising income for our expanded trust portfolio. Our integration continues with minimal disruption to operations, as demonstrated by the leasing success achieved across our entire portfolio."

#### 1 Market Street, Sydney

Seven leases have been executed at 1 Market Street totalling 3,067m<sup>2</sup>. The average lease term is approximately 6 years at an average commencing rent of \$521m<sup>2</sup> gross p.a. Details of the major leasing transactions for 1 Market St are outlined below.

Watabe Australia Pty Ltd has renewed for a further three year term over its existing tenancy on level 19, representing 610m<sup>2</sup>. The new rental has been struck at \$530m<sup>2</sup> p.a. gross with annual 4% increases, effective April 2003.

Coty Australia Pty Ltd has renewed on a six year term on level 31 (591m²) commencing February 2004. The starting rent is \$550m² p.a. gross with annual 3% increases and a market review in year four.

Clarke Cohen Management Pty Ltd has signed a new ten year lease for 500m<sup>2</sup> on part of level 10, commencing 1 December 2003. The commencing rental is \$475m<sup>2</sup> p.a. gross with fixed annual reviews of 4% and market reviews in Years 5 and 9.

### **55 Market Street, Sydney**

Enacon Parking Pty Ltd has renewed for a further term of 5 years over 696m<sup>2</sup> of level 20. The new rental has been agreed at \$545m<sup>2</sup> gross with reviews 2 yearly to market with a ratchet, effective 1 July 2003.

# 201 Kent Street (Maritime Trade Towers), Sydney

Austrade has renewed for a further ten year term over levels 22 and 23 representing 2,650m<sup>2</sup>. The starting new rental is \$450m<sup>2</sup> p.a. net p.a. with 3.5% annual increases and is effective from 1 May 2004.

A further five leases have been executed at Maritime Trade Towers totalling 1,519m<sup>2</sup>, at an average commencing rent of \$440m<sup>2</sup> net p.a. The average lease term is approximately 3.8 years.

### 31 Market Street (St Martin's Tower), Sydney

Spruson and Ferguson has signed a new lease over levels 23, 31, 32, 33 and part 35, for a term of 10 years over an area of 3,129m<sup>2</sup>. The lease commences on 1 January 2004.

Additionally, a further six leases have been executed at 31 Market Street representing 921m<sup>2</sup> at an average lease term of approximately 4 years. The average commencing rent is \$375m<sup>2</sup> net p.a.

# 225 George St (Grosvenor Place), Sydney

Four leases have been executed at 225 George St representing an area of 1,367m<sup>2</sup> with an average lease term of approximately 4 years.

### 33 Bligh St (Kindersley House), Sydney

Eleven new leases have been agreed and executed at Kindersley House totalling 1,316m<sup>2</sup>. The average lease term is approximately 3 years with an average commencing rent of \$344m<sup>2</sup> p.a. gross. Each lease contains a six month development clause.

### 110 George St, Parramatta

Road Transport Authority has signed a new three year lease for 339m<sup>2</sup> effective August 2003.

#### **120 Collins St, Melbourne**

Business Council of Australia has signed a new five year lease on Level 42, commencing January 2004.

Acumen Alliance has leased an area of 675m<sup>2</sup> on level 42 on a five year lease. Part of the lease will start by 1 Dec 2003, with gradual take up of full tenancy by Nov 2004.

#### **109 St Georges Terrace, Perth**

Barwick Partners has signed a new ten year lease for 538m<sup>2</sup> on level 18, commencing 1 October 2003. The starting rental is \$165m<sup>2</sup> p.a. net with fixed annual 3.5% increases and a market review in year 7.
