**ALLOTMENT OF 50,000 MINCOR RESOURCES NL SHARES – (EXERCISE OF UNLISTED OPTIONS)
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

Mincor Resources NL ("**Company**") wishes to announce that it has allotted 50,000 fully paid ordinary shares ("**Securities**") pursuant to the exercise of 50,000 unlisted executive options, each with an exercise price of \$1.74 and an expiry date of 19 October 2011. Disclosure - Secondary Trading Exemption
