**ALLOTMENT OF 83,333 MINCOR RESOURCES NL SHARES – (EXERCISE OF UNLISTED OPTIONS)
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")**

Mincor Resources NL ("**Company**") wishes to announce that it has allotted 83,333 fully paid ordinary shares ("**Securities**") pursuant to the exercise of 83,333 unlisted executive options, each with an exercise price of \$0.85 and an expiry date of 8 May 2011.
