#### **Cleansing Notice**

We refer to the issue of a convertible security by Novogen Limited (**Novogen**) (**ASX: NRT**) on 4 July 2013. Pursuant to a notice of conversion of a portion of the convertible security representing in aggregate \$100,000, Novogen issued 675,676 ordinary shares to Merrill Lynch (Australia) Nominees Pty Limited ACN 003 925 031 FBO Hudson Bay Master Fund Limited on 14 August 2013 (**Shares**).
