ANNEXURE 1

Consideration comprises:

1. 9 OneSteel shares for every 22 shares held in Smorgon Steel Group Ltd (ABN 38 082 181 726) (*Smorgon Steel*) held by scheme shareholders on the scheme record date (10 August 2007); and
2. an amount of cash (if any) determined in accordance with the following formula:

$$\$1.76 - (9/22 \times \text{OneSteel Pricing VWAP})$$

Subject to:

- (a) a maximum of \$4.97/22 per Smorgon Steel share; and
- (b) a minimum of \$1.37/22 per Smorgon Steel share.

The OneSteel Pricing VWAP means the volume weighted average share price (calculated to four decimal places) of OneSteel Shares traded on ASX during the ten consecutive trading days starting on the trading day following the effective date (estimated to be 3 August 2007), excluding:

- (a) all trades which are overseas trades;
- (b) trades which are not an "on market" transaction within the meaning of the Market Rules; and
- (c) any trades which OneSteel and Smorgon Steel reasonably agree to exclude on the basis that they are not representative of the general price at which OneSteel Shares traded on the ASX on the trading day on which the trades took place.
