China Power International Development Limited Announces its Total Electricity Generation for the First Three Quarters of 2005

China Power International Development Limited (the "Company", Stock Code: 2380) today announced its total electricity generation for the first three quarters ended 30 September 2005.

According to its preliminary statistics, the consolidated electricity generation of the power plants of the Company (including the third quarter's electricity generation of Shentou I Power Plant, whose earnings were consolidated with the results of the Company from 1 July 2005, but excluding that of the power plant of the associated company of the Company) for the first three quarters ended 30 September 2005 amounted to 13,908,597MWh, representing an increase of approximately 13.3% compared to the same period last year. Among the power plants of the Company, the total electricity generation of Yaomeng Power Plant and Pingwei Power Plant recorded an increase of approximately 2.0% and a decrease of approximately 9.3% as compared with the same period last year respectively, while the electricity generation of Shentou I Power Plant for the third quarter increased by approximately 3.3% as compared with the same period last year. In addition, the total electricity generation of Changshu Power Plant, a power plant of the associated company of the Company, was 5,642,730MWh, representing a decrease of approximately 11.5% as compared with the same period last year.

The increase in the total electricity generation of the Company for the first three quarters was mainly attributable to (1) the acquisition of Shentou I Power Plant; (2) the increase in installed capacity, decrease in coal consumption and the smooth operation of the generating units after the technical upgrades and overhaul during the first half of the year; and (3) the strengthened management of the generating units with a view to actively implementing its power generation plan.

The respective total electricity generation of the power plants of the Company and its associated company for the first three quarters ended 30 September 2005 and for the third quarter was as follows:

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the leading independent power generating groups in China) and its principal business is to develop, construct, own, manage and operate large power plants in China.

As at 30 September 2005, the Company had 100% ownership in two of its three high-capacity coal-fired power plants under commercial operation, namely, Pingwei Power Plant and Yaomeng Power Plant, and 50% ownership in the remaining one, Changshu Power Plant. These three power plants had a total installed capacity of 3,670MW, and the installed capacity attributable to the Company's ownership in these three power plants is 3,055MW. Subject to completion of the acquisition agreement entered into by the Company on 9 June 2005 in relation to the acquisition of Tianze Development Limited by the Company, the Company will have 100% ownership in Shentou I Power Plant (which has a total installed capacity of 1,200 MW).
