**Total Electricity Generation of
China Power Increased by approximately 28.27% in 2005
compared with 2004**

China Power International Development Limited (the “Company”, Stock Code: 2380) today announced its total electricity generation for the year ended 31 December 2005.

According to its preliminary statistics, the consolidated electricity generation of the power plants of the Company (including the electricity generation of Shentou I Power Plant, whose earnings were consolidated with the results of the Company from 1 July 2005, but excluding that of Changshu Power Plant, the associated company of the Company) for the year ended 31 December 2005 amounted to 20,143,783MWh, representing an increase of approximately 28.27% compared to last year. Among the power plants of the Company, the total electricity generation of Yaomeng Power Plant and Pingwei Power Plant recorded an increase of approximately 3.28% and a slight decrease of 0.2% respectively as compared with last year, while the electricity generation of Shentou I Power Plant for the second half of the year increased by approximately 1.47% as compared with the corresponding period of last year. In addition, the total electricity generation of Changshu Power Plant, a power plant of the associated company of the Company, was 7,514,500MWh, representing a decrease of approximately 6.43% as compared with last year.

The increase in the total electricity generation of the Company for 2005 was mainly attributable to (1) the acquisition of Shentou I Power Plant; (2) the increase in installed capacity and reliability of the generating units after the technical upgrades and overhaul during the first half of the year; and (3) the strengthened management of the production operations with a view to actively implementing its power generation plan.



The respective total electricity generation of the power plants of the Company and its associated company for the year ended 31 December 2005 and for the fourth quarter was as follows:

The shares of the Company have been listed on the Main Board of The Stock Exchange of Hong Kong Limited since 15 October 2004. The Company is the flagship company of China Power Investment Corporation (one of the leading independent power generating groups in China) and its principal business is to develop, construct, own, manage and operate large power plants in China.

The Company had 100% ownership in three of its four high-capacity coal-fired power plants under commercial operation, namely, Pingwei Power Plant, Yaomeng Power Plant and Shentou I Power Plant, and 50% ownership in the remaining one, Changshu Power Plant. These four power plants had a total installed capacity of 4,870MW, and the installed capacity attributable to the Company's ownership in these four power plants is 4,255MW.
