## SUMMARY

The Offer Price has been determined at HK\$2.025 per Offer Share (excluding the brokerage fee, the SFC transaction levy, the investor compensation levy and the Stock Exchange trading fee payable thereon).

The Directors are pleased to announce that a total of 16,343 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** application forms and through giving **electronic application instructions** to HKSCC for a total of 4,933,910,000 Shares, equivalent to approximately 98.7 times of the total number of 50,000,000 Shares initially available for subscription under pool A and pool B of the Hong Kong Public Offering.

As a result of the over-subscription in the Hong Kong Public Offering, the clawback mechanism as specified in the section headed "Structure of the Global Offering" in the Prospectus has been applied. A total of 150,000,000 Shares initially available for subscription under the International Placing have been reallocated to the Hong Kong Public Offering. As a result of such reallocation, there are 200,000,000 Shares available for subscription under the Hong Kong Public Offering, representing 40% of the total number of Shares initially available under the Global Offering (without taking into account any Shares which may be allotted and issued pursuant to the exercise of the Over-allotment Option).

The Shares initially offered under the International Placing were significantly over-subscribed. BNP Paribas Peregrine has over-allocated an aggregate of 75,000,000 Shares under the International Placing, representing 15% of the total number of Offer Shares initially available under the Global Offering.

## DETERMINATION OF FINAL OFFER PRICE

The Offer Price was agreed between the Company and BNP Paribas Peregrine (on behalf of the Underwriters) at HK\$2.025 per Offer Share (excluding the brokerage fee, the SFC transaction levy, the investor compensation levy and the Stock Exchange trading fee payable thereon). At the Offer Price of HK\$2.025 per Share, the net proceeds from the Global Offering, after deducting commissions and expenses and assuming that the Over-allotment Option is not exercised at all, are estimated to be approximately HK\$949.2 million. If the Over-allotment Option is exercised in full at the Offer Price of HK\$2.025 per Share, the Company will receive additional net proceeds of approximately HK\$148.1 million.

## APPLICATIONS RECEIVED AND ALLOCATION OF HONG KONG OFFER SHARES

A total of 50,000,000 Shares were initially available for subscription under pool A and pool B of the Hong Kong Public Offering to satisfy demand for applications made on **WHITE** and **YELLOW** application forms and through giving **electronic application instructions** to HKSCC.

The Directors are pleased to announce that at the close of the application lists at 12:00 noon on 8 December 2005, a total of 16,343 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** application forms and through giving **electronic application instructions** to HKSCC for a total of 4,933,910,000 Shares, equivalent to approximately 98.7 times of the total number of 50,000,000 Shares initially available for subscription under pool A and pool B of the Hong Kong Public Offering, of which a total of 15,942 valid applications in respect of a total of 2,086,910,000 Shares were for Shares with subscription amount of HK\$5 million or less each (equivalent to approximately 83.5 times of the total number of 25,000,000 Shares initially available for allocation in pool A of the Hong Kong Public Offering), and a total of 401 valid applications in respect of a total of 2,847,000,000 Shares were for Shares with subscription amount of more than HK\$5 million each (equivalent to approximately 113.9 times of the total number of 25,000,000 Shares initially available for allocation in pool B of the Hong Kong Public Offering).

There were 16 multiple applications or suspected multiple applications. Applications not based on the denominations set out in the application forms or otherwise not in accordance with the instructions set out therein were rejected. No application for more than 100% of the Hong Kong Offer Shares initially being offered to the public for subscription under either pool A or pool B of the Hong Kong Public Offering (i.e. more than 25,000,000 Shares) has been identified. The Hong Kong Offer Shares were conditionally allocated on the basis set out in the paragraph headed “Basis of Allotment under the Hong Kong Public Offering” below.

As a result of the over-subscription in the Hong Kong Public Offering, the clawback mechanism as specified in the section headed “Structure of the Global Offering” in the Prospectus has been applied. A total of 150,000,000 Shares initially available for subscription under the International Placing have been reallocated to the Hong Kong Public Offering. As a result of such reallocation, there are 200,000,000 Shares available for subscription under the Hong Kong Public Offering, representing 40% of the total number of Shares initially available under the Global Offering (without taking into account any Shares which may be allotted and issued pursuant to the exercise of the Over-allotment Option), whereas the total number of International Placing Shares available for subscription under the International Placing has been reduced to 300,000,000 Shares, representing 60% of the total number of Shares initially available under the Global Offering (without taking into account any Shares which may be allotted and issued pursuant to the exercise of the Over-allotment Option).

As at the date of this announcement, the Over-allotment Option has not been exercised.
