**SECTION 708A NOTICE**

On December 22 and December 23, 2010, Marengo Mining Limited (“**Marengo**” or the “**Company**”) issued a total of 143,000,000 ordinary shares (“**Securities**”) in accordance to the release condition of subscription receipts and pursuant to the Preliminary Short Form Prospectus dated 18 November 2010 and Final Short Form Prospectus dated 30 November 2010.

**Secondary Trading Exemption**
