Please find attached Appendix 4C for Neuren Pharmaceuticals Limited for the first quarter ended 31 March 2006. The results presented are consistent with the Company's expectations:

- (a) set out in the prospectus dated 15 November 2004 and the supplementary prospectus dated 23 December 2004 in support of the Company's February 2005 IPO, together with;
- (b) changes to the business plan as noted in the Company's Interim and Annual Reports for 2005, where following discussions with the FDA Neuren is to move straight to a Phase 3 study for Glypromate® rather than the planned Phase 2b study, and the Glypromate® clinical development programme will accelerate by two years; and
- (c) in December 2005 the Company completed a private placement of 12 million ordinary shares, raising an additional NZ\$6.3 million net of equity raising costs.

In addition, the Company holds its cash balances predominantly in the expected currency of future expenditure and as a result of the significant depreciation of the New Zealand dollar against most major currencies in the quarter ended 31 March 2006, a foreign exchange gain on cash balances has been recognised.
