## CHINA WIRELESS TECHNOLOGIES LANDS RMB 460 MILLION CONTRACT TO SUPPLY UNICOM WITH 180,000 "COOLPAD 288" DUAL-MODE SMARTPHONES COMPANY SET TO ACCELERATE EXPANSION IN CHINA MARKET

Subsequent to the introduction of two high-end products, "Coolpad 728" and its more advanced "Coolpad 728B" which is equipped with additional functions such as Bluetooth and name card scanning, the Company introduces "Coolpad 288", a less expensive smartphone into the mid-tier market. This is to echo its two-pronged marketing strategy that emphasizes the simultaneous development of both middle and high-end markets.

We will also develop the mid and high-end markets simultaneously so as to capture larger market shares and further reinforce our leading position in the domestic market for dual-mode smartphone. Though there are competitors in the dual mode smartphone market, China Wireless Technologies has reinforced its presence as a pioneer and have continually set the standard in such technologies. With further enhancement of our product portfolio, we believe we will maintain our leading position in this market segment." The order of CDMA-GSM "Coolpad 288" dual-mode smartphones will be delivered in phases in the fourth-quarter of 2006 and the first half of 2007.

Users of "Coolpad 288" dual-mode smartphones can switch freely between GSM and CDMA networks. The smartphone can also allow two SIM cards to operate simultaneously, saving users from having to switch SIM cards for different numbers or carrying two mobile phones at the same time.

Operated on the Windows system, "Coolpad 288" allows users to enter data using a mini keyboard. It is equipped with a dual-CPU (central processing units) for processing data at high speeds and is fitted with a 2.5 inch, 260,000 pixel color TFT (thin-film-transistor liquid-crystal-display) monitor and a 2M pixel camera is pre-installed with 128M memory module. It is also equipped with incoming calls firewall function. It can support a maximum extension of 1G T-Flash and be used as a USB flash drive. It also supports PDA functions, browsing of Windows Office format documents, sending and receiving emails as well as wireless communications including Internet Explorer wireless Internet access, MSN and QQ. Also, users can receive stock market information through the smartphones. The "Coolpad 288" smartphone enables users to manage their business as well as enjoy leisure activities anytime and anywhere.
