#### 2. GENERAL MANDATE TO REPURCHASE SHARES AND WARRANTS

In addition, approval is being sought from the shareholders of the Company (the "Shareholders") to repurchase ordinary share(s) of HK\$0.10 each in the share capital of the Company (the "Shares") and warrant(s) issued by the Company in the proportion of one warrant for every five shares held, carrying rights to subscribe for Shares on the basis of an initial subscription price of HK\$1.508 per Share (subject to adjustment), at any time from 2 June 2004 until 31 May 2006 (both days inclusive) (the "Warrants"). At the Annual General Meeting, an ordinary resolution will be proposed to approve the granting of a general mandate to the Directors to exercise the powers of the Company to repurchase (the "Repurchase Mandate"):–

- (i) Shares representing up to a maximum of 10 per cent. of the aggregate nominal amount of the share capital of the Company in issue; and

- (a) the Chairman;
- (b) at least three members present in person or by proxy for the time being entitled to vote at the meeting; or
- (c) any member(s) present in person or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
- (d) any member(s) present in person or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right.

#### 6. RECOMMENDATION

Particulars of the retiring Directors subject to re-election at the Annual General Meeting are set out below:

MR. CHE SHUJIAN, aged 62, has been the Chairman and an Executive Director of the Company since June 2000 and holds chairmanship in a subsidiary and directorship in an associated company of the Group. He is also the Chairman of China Travel Service (Holdings) Hong Kong Limited ("CTS Holdings"), the controlling shareholder of the Company. He is a director of China Insurance International Holdings Company Limited (a company listed in Hong Kong) and serves as a member of National Committee of the Chinese People's Political Consultative Conference. He was a director of China Overseas Land & Investment Ltd. (a company listed in Hong Kong) from September 2002 to September 2003.

There is no service contract between the Company and Mr. Che. He is not appointed for a specific term but shall be subject to retirement and re-election at the annual general meeting in accordance with the articles of association of the Company. Mr. Che received a director's fee of HK\$260,000 for the year ended 31 December 2004 as determined by the Board and subject to the approval from time to time in general meeting of the Company.

MR. LO SUI ON, aged 54, has been the Vice Chairman of the Company since December 2003 and an Executive Director of the Company since June 2000. He is also a director and the general manager of China Travel Service (Hong Kong) Limited ("CTSHK"), a wholly owned subsidiary of the Company and holds directorships in several subsidiaries of the Group. He is also a director of CTS Holdings. Mr. Lo is a member of Hong Kong Tourism Board, a member of The Election Committee for the Second Government of the HKSAR, a member of the HKSAR Government's Election Committee on Deputy of the Tenth National People's Congress of the PRC, a committee member of the Ninth Chinese People's Political Consultative Committee of Inner Mongolia Autonomous Region of China, the chairman of Committee on Tourism of the Hong Kong Chinese Enterprises Association and the president of Hong Kong Association of China Travel Organisers Limited. In addition, Mr. Lo served as a director of the Travel Industry Council of Hong Kong and a member of the Tourism Strategy Group of HKSAR Government.

There is no service contract between the Company and Mr. Lo. He is not appointed for a specific term but shall be subject to retirement and re-election at the general meeting in accordance with the articles of association of the Company. For the year ended 31 December 2004, he received a monthly salary of HK\$51,220 from CTSHK plus discretionary bonus that is subject to the performance of CTSHK and a director's fee of HK\$190,000 as determined by the Board and subject to the approval from time to time in general meeting of the Company.

**MR. CHEN SHOUJIE**, aged 60, has been an Executive Director of the Company since June 2000 and holds directorships in several subsidiaries of the Group. He is also a director and the deputy general manager of CTS Holdings.

There is no service contract between the Company and Mr. Chen. He is not appointed for a specific term but shall be subject to retirement and re-election at the general meeting in accordance with the articles of association of the Company. He received a director's fee of HK\$190,000 for the year ended 31 December 2004 as determined by the Board and subject to the approval from time to time in general meeting of the Company.

MR. LIU LI, aged 51, has been an Executive Director and the Deputy General Manager of the Company since February 2002 and hold directorships in subsidiaries of the Group. He is a qualified senior auditor and Certified Public Accountants of China.

There is no service contract between the Company and Mr. Liu. He is not appointed for a specific term but shall be subject to retirement and re-election at the general meeting in accordance with the articles of association of the Company. For the year ended 31 December 2004, he received a monthly salary of HK\$80,000 from the Company plus discretionary bonus that is subject to the performance of the Company and a director's fee of HK\$190,000 as determined by the Board and subject to the approval from time to time in general meeting of the Company.

MR. WONG MAN KONG, PETER B.B.S., J.P., BSc, F.C.I.T., MRINA, aged 56, has been an Independent Non-Executive Director of the Company since December 1998 and is the Chairman of Audit Committee and Remuneration Committee of the Company. He serves as a deputy of the Tenth National People's Congress of the PRC. Mr. Wong is the chairman of M.K. Corporation Ltd. and North West Development Ltd., as well as a director of several companies listed in Hong Kong, namely Hong Kong Ferry (Holdings) Co. Ltd., Glorious Sun Enterprises Limited, Sun Hung Kai & Co., Limited and Chinney Investments, Limited and Sino Hotels (Holdings) Limited.

There is no service contract between the Company and Mr. Wong. He is not appointed for a specific term but shall be subject to retirement and re-election at the general meeting in accordance with the articles of association of the Company. He received a director's fee of HK\$200,000 for the year ended 31 December 2004 as determined by the Board and subject to the approval from time to time in general meeting of the Company.

MR. SZE, ROBERT TSAI TO, aged 64, has been an Independent Non-Executive Director of the Company since January 2005 and is a member of Audit Committee and Remuneration Committee of the Company. He is a fellow member of the Institute of Chartered Accountants in England and Wales and the Hong Kong Institute of Certified Public Accountants. Mr. Sze was a partner in an international firm of accountants with which he practised for over 20 years. He is a non-executive director of a number of Hong Kong listed companies, Asia Satellite Telecommunications Holdings Limited, Dah Sing Banking Group Limited, Dah Sing Financial Holdings Limited, First Mobile Group Holdings Limited, Hop Hing Holdings Limited, Min Xin Holdings Limited, Nanyang Holdings Limited, QPL International Holdings Limited, SW Kingsway Capital Holdings Limited and Television Boardcasts Limited. He serves as a member of the Shanghai Committee of The Chinese People's Political Consultative Conference.

#### PARTICULARS OF RETIRING DIRECTORS

Save as disclosed herein, none of the Directors to be re-elected at the Annual General Meeting has any relationship with any directors, senior management or substantial or controlling shareholders of the Company, nor holds any directorship in other listed public companies in the last three years. As at 20 April 2005, being the latest practicable date prior to the printing of this circular for the purpose of ascertaining certain information in this circular, none of the Directors to be re-elected at the Annual General Meeting has any interest in the shares of the Company (within the meaning of Part XV of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong)). The Company confirms that there are no other matters with respect to the Directors to be re-elected at the Annual General Meeting that need to be brought to the attention of the Shareholders.

The following is the Explanatory Statement required to be sent to the Shareholders under the Listing Rules in connection with the general mandate for repurchase of Shares and Warrants and, together with the letter from the board contained in this circular, also constitutes the memorandum of the terms of the repurchase required under section 49BA(3)(b) of the Companies Ordinance.

#### GENERAL MANDATE FOR REPURCHASE OF SHARES AND WARRANTS

#### (a) Share Capital and outstanding Warrants

As at 20 April 2005 (the "Latest Practicable Date"), being the latest practicable date prior to the printing of this circular for the purpose of ascertaining certain information contained in this circular, the issued share capital of the Company was HK\$464,415,415.00 divided into 4,644,154,150 Shares and the total amount of the outstanding Warrants was HK\$1,219,415,066.94 carrying the rights to subscribe for up to 808,630,681 Shares at the current subscription price of HK\$1.508 per Share. Subject to the passing of the resolution granting the proposed Repurchase Mandate and on the basis that no further Shares will be issued (whether generally or pursuant to the exercise of the subscription rights attaching to the Warrants) or repurchased before the Annual General Meeting, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 464,415,415 Shares (representing 10% of the said total number of issued shares) and of a total amount of HK\$121,941,506.69 of the Warrants (representing 10% of the said total amount of the outstanding warrants) carrying rights to subscribe for up to 80,863,068 Shares at the current subscription price of HK\$1.508 per Share during the period ending on the earlier of (i) the conclusion of the next annual general meeting of the Company; (ii) the date by which the next annual general meeting of the Company is required to be held by the articles of association of the Company or by the laws of Hong Kong; or (iii) the date upon which such authority is revoked or varied by a resolution of the shareholders of the Company in general meeting.

#### (b) Reasons for Repurchases

The Directors believe that it is in the best interests of the Company and its shareholders to have a general authority from the Shareholders to enable the Directors to repurchase securities in the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the value of the Company's securities and/or its earnings per Share and will only be made when the Directors believe that such repurchases will benefit the Company and its shareholders.

No connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she has a present intention to sell Shares and/or Warrants to the Company, or has undertaken not to do so, in the event that the Company is authorised to make repurchases of Shares and/or Warrants.

The Directors have undertaken to the Stock Exchange that they will exercise the power of the Company to make repurchases pursuant to the Repurchase Mandate in accordance with the Listing Rules and the laws of Hong Kong and the Articles.

#### APPENDIX II

#### (g) General

Upon the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company will increase. Such increase will be treated as an acquisition for the purposes of the Hong Kong Code on Takeovers and Mergers (the "Takeovers Code"). As a result, a Shareholder or a group of Shareholders, acting in concert could, depending on the level of increase of shareholding interest, obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

If the Repurchase Mandate is exercised in full (assuming no Warrants or Convertible Bonds are converted), the beneficial interests of CTS Holdings in the Company may be increased to approximately 59.68 per cent. of the issued share capital of the Company. The Directors consider that such repurchases made under the Repurchase Mandate will not give rise to an obligation for CTS Holdings to make a mandatory offer under Rules 26 and 32 of the Takeovers Code. Moreover, the Directors have no present intention to exercise the power of the Company to repurchase Shares to such an extent as would result in the number of Shares in public hands falling below 25 per cent.

- (C) the aggregate nominal amount of share capital allotted, issued or dealt with or agreed conditionally or unconditionally to be allotted, issued or dealt with (whether pursuant to an option, warrant or otherwise) by the Directors of the Company pursuant to the approval in paragraph (A) above, otherwise than pursuant to (i) a Rights Issue (as hereinafter defined), (ii) any option scheme or similar arrangement for the time being adopted for the grant or issue to officers and/or employees of the Company and/or any of its subsidiaries of shares or right to acquire shares of the Company, (iii) the exercise of rights of subscription or conversion under the terms of any warrants issued by the Company or any securities which are convertible into shares of the Company (including, without limitation, the US\$150,000,000 Zero Coupon Guaranteed Convertible Bonds due 2008 issued by China Chance Developments Limited which are convertible into shares of, and guaranteed by, the Company) or (iv) any scrip dividend or similar arrangement providing for the allotment of shares in lieu of the

whole or part of a dividend on shares of the Company in accordance with the articles of association of the Company, shall not exceed the aggregate of:

- (a) 20% of the aggregate nominal amount of the share capital of the Company in issue at the date of passing this Resolution; and
- (b) (if the Directors are so authorised by a separate ordinary resolution of the shareholders of the Company) the nominal amount of shares of the Company repurchased by the Company subsequent to the passing of this Resolution (up to a maximum equivalent to 10% of the aggregate nominal amount of the shares of the Company in issue at the date of passing this Resolution), and the said approval shall be limited accordingly:
- (D) for the purpose of this Resolution:

"Relevant Period" means the period from the passing of this Resolution until whichever is the earlier of:—

- (i) the conclusion of the next annual general meeting of the Company;
- (ii) the expiration of the period within which the next annual general meeting of the Company is required by the articles of association of the Company or by the laws of Hong Kong to be held; or
- (iii) the revocation or variation of the authority given under this Resolution by ordinary resolution of the shareholders in general meeting; and

"Rights Issue" means an offer of shares or securities open for a period fixed by the Directors of the Company to holders of shares of the Company or any class thereof on the register on a fixed record date in proportion to their then holdings of such shares or class thereof (subject to such exclusion or other arrangements as the Directors of the Company may deem necessary or expedient in relation to fractional entitlements or having regard to any restrictions or obligations under the laws of, or the requirements of any recognised regulatory body or any stock exchange in, any territory outside Hong Kong)."

7. **"THAT** the Directors of the Company be and are hereby authorised to exercise the powers of the Company referred to in paragraph (A) of the resolution set out as Resolution No. 6 in the notice convening this Meeting in respect of the nominal amount of shares of the Company referred to in sub-paragraph (b) of paragraph (C) of such resolution."
