INTRODUCTION

The Company will propose at the AGM resolutions to re-elect the retiring Directors and to dispose of vacant office(s) and grant to the Directors the general mandates for issue of Shares and repurchase by the Company of its own Shares. The latest general mandates granted to the Directors were approved in the Company's annual general meeting held on 17th June, 2005.

The purpose of this circular is to provide you with further information and details about these resolutions to be proposed at the AGM.

LETTER FROM THE CHAIRMAN

ANNUAL GENERAL MEETING

A notice convening the AGM is set out in Appendix IA to this circular. At the AGM, resolutions will be proposed to approve, inter alia, the re-election of Directors and the general mandates to issue Shares and repurchase Shares.

The procedure by which Shareholders may demand a poll at any general meeting of the Company is set out in Appendix IB to this circular.

RE-ELECTION OF DIRECTORS

In accordance with Bye-law 99 of the Company's Bye-laws and Code Provision A.4 under Appendix 14 to the Listing Rules, Mr. Budiono Widodo, Mr. Sardjono Widodo, Mr. Liao Yun Kuang, and Mr. Kusnadi Pipin will retire at the AGM and, being eligible, will offer themselves for re-election. Information of these retiring directors as required to be disclosed under the Listing Rules is set out in Appendix II to this circular.

GENERAL MANDATE FOR ISSUE OF SHARES

Pursuant to Bye-law 70 to Bye-law 74 of the Company's Bye-laws, at any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is required under the rules of the relevant board of the stock exchange in the Relevant Territory or a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded by:–

- (i) the chairman of the meeting; or
- (ii) at least three shareholders present in person (or, in the case of a shareholder being a corporation, by its duly authorized representative) or by proxy for the time being entitled to vote at the meeting; or
- (iii) any shareholder or shareholders present in person (or, in the case of a shareholder being a corporation, by its duly authorized representative) or by proxy and representing not less then one-tenth of the total voting rights of all the shareholders having the right to vote at the meeting; or
- (iv) any shareholder or shareholders present in person (or, in the case of a shareholder being a corporation, by its duly authorized representative) or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right.

Unless a poll be so required or so demanded and the demand is not withdrawn, a declaration by the chairman that a resolution has on a show of hands been carried or carried unanimously, or by a particular majority, or lost, and an entry to that effect in the book containing the minutes of the proceedings of the Company shall be conclusive evidence of the fact without proof of the number of proportion of the votes recorded in favour or against such resolution.

He is also a director of each of the subsidiaries of the Company except Glowing schemes Sdn. Bhd. He started in the forestry business in Indonesia in 1979 and has over 15 years of experience in the timber industry, starting as a log exporter and then becoming a plywood manufacturer and trader. Apart from the plywood business, he is also engaged in other industries including property and hotels.

Mr. Widodo has a service contract with the Company for a term of one year from 1st July, 2005 and his remuneration under this service contract includes a fixed salary of approximately US\$456,000 per annum, a management bonus, equivalent to 50% of the Management Bonus Fund and other fringe benefits. Mr. Widodo is the father of Mr. Sardjono Widodo, Managing Director of the Company, and the father-in-law of Mr. Sudjono Halim, a non-executive director of the Company, and the controlling shareholder of the Company. Mr. Widodo has personal and corporate interests in 2,222,996,000 Shares within the meaning of Part XV of SFO.

Save as disclosed above, there is no information to be disclosed pursuant to any of the requirements under paragraph 13.51(2) of the Listing Rules and there are no other matters relating to his re-election that need to be brought to the attention of the Shareholders.

Mr. Sardjono Widodo, aged 38, is the Managing Director of the Group and a son of Mr. Budiono Widodo. He is also a director of each of the subsidiaries of the Company except Glowing Schemes Sdn. Bhd. He holds a Diploma in Mechanical Engineering and has been in the wood industry for over 10 years.

Mr. Widodo has a service contract with the Company for a term of one year from 1st July, 2005 and his remuneration under this service contract includes a fixed salary of approximately US\$180,000 per annum, a management bonus, equivalent to 20% of the Management Bonus Fund and other fringe benefits. Mr. Widodo is not interested in the Shares within the meaning of Part XV of SFO.

Save as disclosed above, there is no information to be disclosed pursuant to any of the requirements under paragraph 13.51(2) of the Listing Rules and there are no other matters relating to his re-election that need to be brought to the attention of the Shareholders.

Mr. Liao Yun Kuang, aged 53, is the President of the Group. He is also a director of each of the subsidiaries of the Company except Changchun Winpro Wood Industries Co., Ltd. He holds a Bachelor Degree in Business Administration from Tam Kang University in Taiwan. Prior to joining the timber industry, Mr. Liao has worked for two large conglomerates in Taiwan and has more than 10 years experience in general management.

APPENDIX II

Mr. Liao has a service contract with the Company for a term of one year from 1st July, 2005 and his remuneration under this service contract and other arrangement with the Company includes a fixed salary of approximately US\$135,000, a management bonus, equivalent to 12% of the Management Bonus Fund and other fringe benefits. Mr. Liao has no relationship with any directors or senior management or substantial or controlling shareholders of the Company. Mr. Liao is not interested in the Shares within the meaning of Part XV of SFO.

Save as disclosed above, there is no information to be disclosed pursuant to any of the requirements under paragraph 13.51(2) of the Listing Rules and there are no other matters relating to his re-election that need to be brought to the attention of the Shareholders.

Mr. Pipin Kusnadi, aged 60, is the commissioner for over 10 companies in Jakarta and has been in the wood industry since 1991.

The appointment of Mr. Pipin as a non-executive director of the Company is for a term of one year from 28th June, 2005 and his annual director's remuneration is HK\$50,000. Mr. Pipin is a shareholder of and holds 5.4% interests in SMI International Limited, the Controlling Shareholder of the Company. Mr. Pipin is not interested in the Shares within the meaning of Part XV of SFO.

APPENDIX III EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to you for your consideration in relation to the repurchase mandate as set out in resolution no. 4(B) of the notice of the AGM.

1. LISTING RULES

The Listing Rules permit companies with their primary listing on the Stock Exchange to repurchase their shares on the Stock Exchange subject to certain restrictions, the most important of which is:–

Sources of funds

Repurchase must be funded entirely from the Company's available cash flow or working capital facilities, which will be funds legally available for the purpose and in accordance with the memorandum of association and bye-laws of the company concerned and The Companies Act 1981 of Bermuda (as amended).

2. SHARE CAPITAL

As at the Latest Practicable Date, the Company has issued 5,580,897,243 Shares.

Subject to the passing of resolution no. 4(B) set out in the notice of the AGM and on the basis that no further Shares are issued prior to the AGM, the Company would be allowed under the repurchase mandate to purchase a maximum of 558,089,724 Shares, representing 10% of the issued share capital of the Company as at the date of passing the resolution.

3. **REASONS FOR REPURCHASE**

The Directors believe that the granting of repurchase mandate is in the best interests of the Company and its shareholders. The exercise of the repurchase mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets of the Company and/or earnings per share and will only be made when the Directors believe that such a purchase will benefit the Company and the Shareholders.

4. FUNDING OF REPURCHASES

In repurchasing shares, the Company may only apply funds entirely from the Company's available cash flow or working capital facilities, which will be funds legally available for such purpose in accordance with its memorandum of association and byelaws and The Companies Act 1981 of Bermuda (as amended). The Directors propose that repurchases of Shares be financed by the Company's distributable profits or proceeds from a fresh issue of Shares.

APPENDIX III EXPLANATORY STATEMENT ON THE REPURCHASE MANDATE

There might be an adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report for the year ended 31st December, 2005) in the event that repurchase mandate is carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise their power under the repurchase mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels in the opinion of the Directors are from time to time appropriate for the Company.

No other connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company or have undertaken not to do so, in the event that the repurchase mandate is approved by the Shareholders.

As at the Latest Practicable Date, SMI International Limited ("SIL") had registered an interest in 1,974,720,000 Shares representing approximately 35.38% of all the issued Shares. If the repurchase mandate is exercised in full, SIL's interest in the Company will be increased to 39.32%.

If on the exercise of the power to repurchase shares of the Company pursuant to the repurchase mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 8 of the Hong Kong Code on Share Repurchases. As a result, a Shareholder or group of Shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 and 32 of the Takeover Code.

Save as disclosed above, the Directors are not aware of any consequences which may arise under the Takeover Code as a result of any purchase of Shares made under the repurchase mandate.

7. SHARES REPURCHASES MADE BY THE COMPANY

The Company had not purchased any of its Shares (whether on the Stock Exchange or otherwise) during the 6-month period prior to the date of this circular.
