Mr Lo has a deemed interest in issued shares of GPBI which arises pursuant to his 29.68% interests in issued shares of Gold Peak Industries (Holdings) Limited ("Gold Peak"), Gold Peak's 82.93% interests in issued shares of GP Industries Limited ("GP Industries") and GP Industries' interests in issued shares of GPBI. GP Industries acquired 706,000 shares of GPBI in the market from 3 to 18 March 2014 and subscribed for 29,376,048 GPB rights shares on 11 March 2014, so Mr Lo's deemed interest in issued shares of GPBI changed.
