Victor Lo Chung Wing ("Mr Lo") has a deemed interest in the issued shares of GP Batteries which arises pursuant to his 29.68% interests in issued shares of Gold Peak Industries (Holdings) Limited ("Gold Peak"), Gold Peak's 84.71% interests in issued shares of GP Industries Limited ("GP Industries") and GP Industries' interests in issued shares of GP Batteries. GP Industries acquired 23,100 GP Batteries shares from the open market of SGX-ST on 23 February 2015 and so Mr Lo's deemed interest in the issued shares of GP Batteries changed.
