ISSUE OF RMG LIMITED SECURITIES – SECONDARY TRADING NOTICE - NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

Further to approval by shareholders in general meeting on 19 November 2014, RMG Ltd ("**Company**") issued the following securities to Chile Metals Consulting SPA:

- 1. 40,108,785 fully paid ordinary shares; and
- 2. 16,000,000 unlisted Options exerciseable at 9.9 cents each on or before 31 August 2016.

Secondary Trading Exemption
