SUCCESSFUL CAPITAL RAISING ISSUE AND ALLOTMENT OF TRANCHE 1 SECURITIES

RMG Limited (ASX: RMG), is pleased to announce the issue of 366,407,689 new shares at \$0.0015 each raising \$549,611 before costs, pursuant to existing capacity to issue shares under its ASX Listing Rule 7.1 (**Tranche 1 Securities**).

RMG Limited announced on 3 July 2014 that it has firm commitments for a placement of 1,866,666,667 shares to a range of existing and new investors to raise \$2,800,000 before expenses. Proceeds from the issue will be used to advance work on the Tuina copper-silver project located in Chile and to meet its obligations on the Kamarga base metal project in North Queensland. The share placement is to be made to sophisticated investors from Australia and overseas. The Company will issue 1,866,666,667 shares at \$0.0015 each along with one free attaching option for every 2 shares successfully placed. The options will have a two year term and expire on 31 August 2016 and will be exercisable at \$0.003 (0.3 cents each).

The placement is to be completed in two stages. The issue of Tranche 1 Securities is now complete. RMG has issued 366,407,689 new shares at \$0.0015 each raising \$549,611 before costs pursuant to existing capacity to issue shares under its ASX Listing Rule 7.1. The balance of the placement of 1,586,666,667 shares and attaching options (Tranche 2 Securities) will be subject to shareholder approval at a general meeting to be held on or about 28 August 2014. The shares will rank equally with all current shares on issue and application for quotation of the shares will be made. The options will be unlisted.

The funding allows the Company to immediately progress work programs at RMG's exciting Tuina project in Chile which will include drilling, IP programs, development of potential near term production opportunities and continued exploration of the Tuina district. Funds will also be applied to meet expenditure requirements at the Kamarga zinc-lead deposit in North Queensland

ISSUE OF RMG LIMITED SECURITIES – SECONDARY TRADING NOTICE - NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

On 16 July 2014, RMG Ltd ("**Company**") issued 366,407,689 fully paid ordinary shares. The shares are the Tranche 1 Securities as per the Company's capital raising announcement released on 3 July 2014. An Appendix 3B is attached to this notice. ("**Securities**").
