If we do not receive the Reply Form from you by **31 October 2012** and until you inform the Company’s share registrar by reasonable notice in writing, only a printed Chinese version of the Company’s Corporate Communication will be sent if you are a shareholder who is a natural person with a Chinese name and has an address in Hong Kong appearing on the register of members of the Company. Otherwise, we will only send you a printed English version of the Company’s Corporate Communication.
