All of the ultimate beneficial owners are merchants. In particular, Mr. William Shum, Mr. Shum and Mr. Tang have extensive experience in watch business. As stated in the Announcement, to the best of the Directors’ knowledge, information and belief, having made all reasonable enquiries, Memorigin and its ultimate beneficial owners are Independent Third Parties.
