The Warrant entitling the holder thereof to subscribe for one ordinary share of the Company at an initial warrant exercise price of HK\$0.147 per share (subject to adjustment) for a period of 24 months commencing from the date of issue of the Warrants.

(2) A total of HK\$648,040.00 Convertible Bonds have been subscribed by the Option Holders during the month of January 2011. (Details please refer to the Company's prospectus dated 15 April 2010 and announcement dated 5 May 2010).
