The Board is pleased to announce that the proposed resolution as set out in the EGM Notice was duly passed by the Shareholders at the EGM held on 30 April 2014 by way of poll.

Reference is made to the circular (the “**Circular**”) and the notice of extraordinary general meeting (the “**EGM Notice**”) of The Hong Kong Building and Loan Agency Limited (the “**Company**”) both dated 11 April 2014 in relation to, among others, the proposed very substantial Acquisition (as defined in the Circular) to be approved at the EGM held on 30 April 2014. Unless otherwise defined therein, capitalized terms used in this announcement shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE EGM

The Board is pleased to announce that the proposed resolution as set out in the EGM Notice was duly passed by the Shareholders at the EGM held on 30 April 2014 by way of poll.

As at the date of the EGM, the total number of issued shares of the Company was 607,641,866 Shares, which was the total number of Shares entitling Shareholders to attend and vote for or against on the proposed resolution at the EGM. No Shareholder was required under the Listing Rules to abstain from voting and no Shareholder was entitled to attend and vote only against the resolution at the EGM. None of the Shareholders was required to abstain from voting in favour of the resolution at the EGM.

The Company's share registrar and transfer office, Tricor Tengis Limited, was appointed as the scrutineer for the vote-taking at the EGM. The poll results are as follows:
