RESIGNATION OF INDEPENDENT NON-EXECUTIVE DIRECTOR

The board (the “**Board**”) of directors (the “**Directors**”) of The Hong Kong Building and Loan Agency Limited (the “**Company**”) hereby announces that Mr. Yeung Wai Hung, Peter (“**Mr. Yeung**”) has tendered his resignation as an independent non-executive Director with effect from 2 June 2018, due to pursuit of his other personal commitments.

Mr. Yeung has confirmed that he has no disagreement with the Board and there is no matter in respect of his resignation that needs to be brought to the attention of the shareholders of the Company or the Exchange.

Following the resignation of Mr. Yeung with effect from 2 June 2018, Mr. Yeung will cease to act as a member of each of the audit committee, remuneration committee and nomination committee of the Company.

According to rules 3.10(1) and 3.21 of the Rules Governing the Listing of Securities on the Exchange (the “**Listing Rules**”), the Company is required to appoint at least three independent non-executive directors and to comprise a minimum number of three members of the audit committee. Following the resignation of Mr. Yeung, the numbers of independent non-executive directors on the Board and the members of the audit committee are less than three as required under rules 3.10(1) and 3.21 of the Listing Rules.

The Company is endeavoring to identify a suitable candidate to act as an additional independent non-executive director to meet the requirements set out in rules 3.10(1) and 3.21 of the Listing Rules as soon as practicable and within the three-month period from the date of Mr. Yeung's resignation and will make further announcement(s) as and when appropriate.

The Board would like to take this opportunity to thank Mr. Yeung for his contribution to the Company during his tenure of the aforesaid offices.
