The Group is principally engaged in the manufacture and sale of power and data cords. Its four key product groups are (i) power and data cords for mobile handsets; (ii) medical control devices; (iii) power cords and inlet sockets for household electric appliances; and (iv) raw cables. Each product group has its own types of products. During the years ended 31 March 2010 and 2009 and the nine months ended 31 December 2010, the Group manufactured over 40 types of power and data cord for mobile handsets, and over 450 types of power cords and inlet sockets for household electric appliances. The Group is also engaged in the manufacture and sale of raw cables without connector plugs for mobile handsets and the assembly and sale of medical control devices which are used primarily by patients in hospital wards and the related accessories.
