The Board is pleased to announce that as the relevant conditions precedent of the Sale and Purchase Agreement have been fulfilled, Completion has taken place on 11 December 2013. Upon Completion, 55,000,000 Consideration Shares at the issue price of HK\$1.50 per Consideration Share and the Promissory Note in the principal amount of HK\$47,500,000 have been issued to the Vendor, and the cash consideration as to HK\$40,000,000 have also been paid to the Vendor as payment of the Consideration for the Acquisition pursuant to the Sale and Purchase Agreement.

Following the completion of the Acquisition, the Target Company has become an indirect wholly-owned subsidiary of the Company.
