**SUPPLEMENTAL AGREEMENT IN RELATION TO
PLACING OF CONVERTIBLE BONDS UNDER GENERAL MANDATE**

Reference is made to the announcement of the Company dated 20 December 2013 in respect of the Placing (the “**Announcement**”). Capitalized terms used in this announcement shall have the same meanings as those defined in the Announcement unless otherwise stated.

On 6 January 2014 (after trading hours), the Company and the Placing Agent entered into the supplemental agreement (the “**Supplemental Agreement**”) to amend, inter alia, the Placing Period to become the period commencing upon the execution of the Placing Agreement and ending on 22 January 2014 (instead of 20 February 2014 as set out in the Announcement), unless terminated earlier pursuant to the terms of the Placing Agreement.

The above amendment was made to bring in line with the market practice as to the duration of the Placing. Save as the amendments under the Supplemental Agreement, all other terms and conditions of the Placing Agreement shall remain unchanged and in full force and effect. The terms of the Supplemental Agreement were arrived at after arm’s length negotiations between the Company and the Placing Agent, and the Directors believe that the terms of the Supplemental Agreement are fair and reasonable and are in the best interests of the Company and the Shareholders as a whole.
