INCORPORATION OF JOINT VENTURE COMPANY

The board of directors (the “**Directors**”) of China Everbright Water Limited (the “**Company**”) wishes to announce that China Everbright Water Management Limited (中國光大水務管理有限公司), a wholly-owned subsidiary of the Company, and Haimen City Dayuan Water Limited (海門市達源水務有限公司) have incorporated a company known as Everbright Water (Haimen) Limited (光大水務(海門)有限公司) (the “**JV Company**”) in the People’s Republic of China.

The JV Company has been incorporated with a registered capital of RMB70,000,000 and a shareholding breakdown as follows:
