Singapore and Hong Kong, 1 December 2021 – China Everbright Water Limited (“Everbright Water” or the “Company”; stock codes: U9E.SG and 1857.HK) (中國光大水務有限公司), an environmental protection company focusing on water environment management, is pleased to announce that the Company received the “ListCo Excellence Award 2021”, which was jointly presented by organisations including the Hong Kong stocks channel of ifeng.com and am730. This represents that Everbright Water’s stable and sustainable operational performance has received recognitions from the capital markets of mainland China and Hong Kong.

The annual “ListCo Excellence Award” is the only recognition for listed companies that is co-organised by media from mainland China and Hong Kong. The judging committee of the award includes fund managers, senior stock commentators and equity analysts from various authoritative financial institutions, with the aim to acknowledge outstanding listed companies as recognised by the business and investment sectors.

Everbright Water has steadily forged ahead with all works and business development over the course of this year. The Company delivered outstanding financial performance in the first half of 2021, with revenue increasing by 47% year-on-year to HKD3.11 billion, profit attributable to equity holders of the Company increased by 36% year-on-year to HKD548 million, and basic earnings per share increased by 36% year-on-year to HK19.16 cents. The Company has invested in and holds 151 water projects, which command an aggregate investment of approximately RMB28 billion and have an aggregate designed daily waste water treatment capacity exceeding 6.9 million m³. In the process of steadily strengthening its business and service capabilities, Everbright Water continues improving the quality of the water environment in areas where it operates and actively engages with local communities through various means, including opening up its facilities for public visits, in an attempt to fulfill its corporate social responsibility.
