RESULTS OF EXTRAORDINARY GENERAL MEETING
HELD ON 10 OCTOBER 2014

The Board is pleased to announce that the resolution in relation to the refreshment of the Existing General Mandate was duly passed by the Independent Shareholders by way of poll at the EGM held on 10 October 2014.

Reference is made to the notice of the extraordinary general meeting of China E-Learning Group Limited (the “**Company**”) dated 23 September 2014 (the “**Notice of EGM**”) and the circular of the Company dated 23 September 2014 (the “**Circular**”). Unless otherwise defined herein, capitalised terms used herein shall have the same meanings as defined in the Circular.

POLL RESULTS OF THE EGM

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that the resolution proposed as set out in the Notice of EGM was duly passed by the Independent Shareholders by way of poll at the extraordinary general meeting of the Company held on 10 October 2014 (the “**EGM**”).

The poll results in respect of the resolution proposed at the EGM are as follows:

As more than 50% of the votes were cast in favour of the resolution, the resolution was duly passed as ordinary resolution of the Company.

Notes:

- (a) The number and percentage of votes are based on the total number of Shares voted by the Independent Shareholders at the EGM in person or by proxy.
- (b) As at the date of the EGM, the total number of Shares in issue was 2,327,600,035 Shares, which represented the total number of Shares entitling the holders to attend and vote for or against the resolution at the EGM.
- (c) As at the date of the EGM, Mr. Li Xiangjun, a non-executive Director, held 313,590 Shares and Mr. Yang Dong Jun, who is the father of Mr. Yang Jilin (an executive Director), held 251,106,896 Shares. As referred to the Circular, Mr. Li Xiangjun, Mr. Yang Dong Jun and their associates abstained from voting in favour of the ordinary resolution pursuant to Rule 17.42A of the GEM Listing Rules. As such, the total number of issued Shares available to vote on the proposed resolution at the EGM was 2,076,179,549 Shares.
- (d) For the above resolution, the Independent Shareholders, authorized proxies or authorized representatives holding in aggregate of 205,713,453 Shares, representing approximately 9.91% of the total number of issued Shares available to vote on the proposed resolution were present at the EGM.
- (e) None of the Independent Shareholders have stated their intention in the Circular to vote against or to abstain from voting on the proposed resolution at the EGM.
- (f) Tricor Tengis Limited, the Company's Hong Kong branch share registrar, acted as the scrutineer at the EGM for the purpose of vote-taking.
