**EXTENSION OF TIME UNDER
THE MEMORANDUM OF COOPERATION**

On 27 May 2017, the Company and Mr. Ma and Mr. Zhao agreed to extend the time for taking practical actions in respect of the Cooperation under the Memorandum of Cooperation for another six months.

Reference is made to the announcement (the “**Announcement**”) of China E-Learning Group Limited (the “**Company**”) dated 28 November 2016 in relation to the Memorandum of Cooperation entered into between the Company and Mr. Ma Liejun (“**Mr. Ma**”) and Mr. Zhao Dongyin (“**Mr. Zhao**”) for the Cooperation. Capitalised terms used herein shall have the same meanings as those defined in the Announcement, unless the contents otherwise require.

On 27 May 2017, the Company and Mr. Ma and Mr. Zhao agreed to extend the time for taking practical actions in respect of the Cooperation under the Memorandum of Cooperation for another six months. Save for the aforesaid amendment, all other terms of the Memorandum of Cooperation remain unchanged and continue to be in full force and effect.

The Cooperation is still under negotiation and discussion between the Parties. **The Cooperation may or may not be consummated, shareholders and investors of the Company should exercise caution when dealings in the Shares.** Further announcement will be made in respect of the Cooperation as and when required by the GEM Listing Rules.
