**UPDATE ON THE USE OF PROCEEDS FROM PLACING OF SHARES**

Reference is made to the announcements issued by China E-Information Technology Group Limited (the “**Company**”) dated 26 January 2018, 9 February 2018 and 27 February 2018 in relation to the Placing (the “**Announcements**”) and the annual report of the Company for the year ended 31 December 2018 (the “**Annual Report**”). Terms used herein shall have the same meanings as defined in the Announcements unless otherwise stated.

As disclosed in the Announcements, the completion of the Placing took place on 27 February 2018 and the net proceeds from the Placing, after deducting related Placing commission, professional fees and all related expenses, was approximately HK\$44.4 million (the “**Proceeds**”). As at the date of this announcement, all the Proceeds have been utilised.

The Board wishes to provide the following additional information to the Shareholders in relation to the actual use of the Proceeds as follows:–

General working capital of the Group and for any possible acquisition and other investment opportunities in the future.

(a) Approximately HK\$16.5 million had been utilised as at 31 December 2018 and approximately HK\$2.9 million had been utilised in January and February 2019 for general working capital of the Group;

- (b) Approximately HK\$10.0 million was utilised in September 2018 as capital investment to a Singapore wholly-owned subsidiary of the Company, Sinzhongyi Consultancy Pte Ltd; and
- (c) Approximately HK\$15.0 million was utilised in December 2018 to subscribe for interests in Ocean Investment New Energy Fund LP.

The abovementioned actual use of the Proceeds are consistent with the intended use of the Proceeds as disclosed in the Announcements and no material delay in the use of the Proceeds is noted.

The above supplemental information does not affect other information contained in the Annual Report and, save as disclosed in this announcement, the contents of the Annual Report remain unchanged.
