On 20 July 2020, the Company entered into the Placing Agreement with the Placing Agent pursuant to which the Company has agreed to appoint the Placing Agent as placing agent for the purpose of procuring, as agent of the Company, on a best effort basis, not less than six Placées to subscribe in cash for the Convertible Bonds in a maximum aggregate principal amount of up to HK\$123,000,000. Assuming upon the full conversion of the Convertible Bonds at the initial Conversion Price of HK\$0.10 per Conversion Share (subject to adjustments), 1,230,000,000 Conversion Shares will be allotted and issued. On 17 August 2020, the Company announced that as certain condition precedent to the Placing Agreement was not fulfilled as at 17 August 2020, the Placing Agreement lapsed on 17 August 2020.
