- (4) to receive both the printed English and Chinese versions of all future Corporate Communication.

Even if you have chosen (or are deemed to have consented) to receive Website Version only but for any reason have difficulty in receiving or gaining access to the Corporate Communication, the Company will upon your request send the Corporate Communication to you in printed form free of charge as soon as possible.
