On 22 November 2019, Zhong Tuo Limited (a wholly-owned subsidiary of the Issuer) entered into the joint venture agreement with 寧波雲霓企業管理合夥企業（有限合夥）(Ningbo Yunni Enterprise Management Partnership (Limited Partnership)*), 寧波雲碼企業管理合夥企業（有限合夥）(Ningbo Yun Ma Enterprise Management Partnership (Limited Partnership)*) and Mr. Ye Cunshi, pursuant to which Zhong Tuo Limited agreed to procure the Issuer to issue 700,655,257 unlisted warrants to Yun Ma Limited at the issue price of HK\$0.001 per warrant as performance incentive. Each warrant carries the right to subscribe at any time during the subscription period for one warrant share at the subscription price of HK\$0.054 (subject to adjustment) per warrant share. The issue of the unlisted warrants is subject to shareholders' approval and the satisfaction of the conditions precedent as set out in the announcement of the Issuer dated 22 November 2019, and the warrant shares to be allotted and issued upon exercise of the subscription rights attaching to the warrants will be allotted and issued under the specific mandate, grant of which is also subject to the shareholders' approval. The relevant extraordinary general meeting is going to be held on or around 13 December 2019.
