On 22 November 2019, Zhong Tuo Limited (a wholly-owned subsidiary of the Issuer) entered into the joint venture agreement with 寧波雲霓企業管理合夥企業（有限合夥）(Ningbo Yunni Enterprise Management Partnership (Limited Partnership)*), 寧波雲碼企業管理合夥企業（有限合夥）(Ningbo Yun Ma Enterprise Management Partnership (Limited Partnership)*) and Mr. Ye Cunshi, pursuant to which Zhong Tuo Limited agreed to procure the Issuer to issue 700,655,257 unlisted warrants to Yun Ma Limited at the issue price of HK\$0.001 per warrant as performance incentive. Each warrant carries the right to subscribe at any time during the subscription period for one warrant share at the subscription price of HK\$0.054 (subject to adjustment) per warrant share. Shareholders of the Company have approved the proposed issue of the unlisted warrants at the extraordinary general meeting held on 13 December 2019. Issue of warrant and the formation of the joint venture company are inter-conditional upon each other. After the formation of the joint venture company and the exercise of the subscription rights attaching to the warrants, the warrant shares will be allotted and issued under the specific mandate.
