## Remarks (if any):

The extraordinary general meeting of the Company was held on 16 March 2021 to approve share consolidation and increase of authorised share capital which became effective on 18 March 2021.

#### As a result of the share consolidation and increase of authorised share capital:

- the share consolidation on the basis that every ten (10) existing shares of HK\$0.01 each be consolidated into one (1) consolidated share of HK\$0.10 each. Upon the share consolidation becoming effective, the authorised share capital of the Company became HK\$10,000,000 divided into 100,000,000 ordinary shares of HK\$0.10 each, of which 90,000,000 consolidated shares in issue.
- upon the increase of authorised share capital becoming effective, the authorised share capital of the Company changed from HK\$10,000,000 divided into 100,000,000 consolidated shares of HK\$0.10 each to HK\$100,000,000 divided into 1,000,000,000 consolidated shares of HK\$0.10 each
