Power Generation and Electricity Sold for the Year 2013

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the year ended 31 December 2013, the combined total power generation of the Company and its subsidiaries (collectively, the “Group”) amounted to 55,582,400MWh, representing an increase of 7.18% year on year while its combined total electricity sold amounted to 52,795,155MWh, representing an increase of 7.30% year on year.

The increase in the cumulative power generation for the year 2013 was mainly due to the increase in the electricity consumption in China and the additional contribution from the Group’s new power generating units which commenced commercial operation during the year. The increase of coal-fired power generation was more substantial during the fourth quarter. It recorded double-digit growth when compared with the same winter period last year.

The respective total power generation and total electricity sold of the Group’s main generating units for the year ended 31 December 2013 were as follows:

Notes:

- (1) The merger of the two power plants, Yaomeng and Yaomeng II came into effect in the fourth quarter. Effective from 1 November 2013, Yaomeng II's power generation and electricity sold included that of Yaomeng, and Yaomeng therefrom ceased commercial operation.
- (2) The two new coal-fired power generating units of CP Shentou of total 1,200MW commenced commercial operation in June and September 2013 respectively.
- (3) The Company completed the acquisition of Wuhu on 25 November 2013. Its power generation and electricity sold were into the Group thereafter.

- (4) The two hydropower plants, Chalingxian Lianguan and Tumuxi, were previously grouped under “Hunan Zhong Shui”.
- (5) The three new hydropower generating units of Baishi of total 420MW commenced commercial operation during April to May 2013.
- (6) The thirty-three new wind power generating units of Burqin of total 49.5MW commenced commercial operation during the year 2013.
- (7) The thirty-three new wind power generating units of Toksun of total 49.5MW commenced commercial operation during the year 2013.
