Adjustments of On-grid Tariffs

China Power International Development Limited (the "Company") announces that it has recently received the notification from the National Development and Reform Commission (the "NDRC") regarding further diverting the coal-fired power generating enterprises to denitration and dedusting environmental protection tariffs, the State decided to make appropriate adjustments to the on-grid tariffs (No. [2014]1908) (the "Notification").

Pursuant to the requirements in the Notification which specified the downward adjustment to the desulphurization benchmark on-grid tariffs for coal-fired power generating enterprises in relevant provinces, the on-grid tariffs (including tax) for the Company's wholly-owned or controlled coal-fired power plants are adjusted as follows:

In addition, for those coal-fired power generating enterprises which have obtained confirmation approval from the relevant environmental protection department for meeting the denitration and dedusting emissions standards, they will continue to receive the denitration and dedusting tariff subsidies of RMB10/MWh and RMB2/MWh respectively.

It is expected that all the coal-fired power generating units of the Company will receive the denitration tariff subsidy by the end of this year. Pingwei Power Plant, Wuhu Power Plant and CP Shentou Power Plant have also obtained the dedusting tariff subsidy, while the remaining power plants which are undergoing the dedusting renovation works will benefit from the dedusting tariff subsidy soon.

The above on-grid tariffs adjustments will be effective from 1 September 2014. After such adjustments on the on-grid tariffs, not including the denitration and dedusting tariff subsidies, the weighted average on-grid tariffs for the installed capacity of the Company's coal-fired power generating units will be decreased by approximately RMB8.78/MWh.
