Power Generation and Electricity Sold for the First Quarter of 2015

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the three months ended 31 March 2015, the combined total power generation of the Company and its subsidiaries (collectively, the “Group”) amounted to 13,702,409MWh, representing a decrease of 11.45% over the same period last year while its combined total electricity sold amounted to 13,132,085MWh, representing a decrease of 10.90% over the same period last year.

During the first quarter of this year, the Group’s hydropower plants principally located along Yuan River Basin in Hunan Province recorded satisfactory growth in power generation. However, the surge in hydropower generation in Sichuan and Hubei Provinces squeezed the space for coal-fired power generation in the regions and plus the Group’s certain coal-fired power generating units suspended for overhaul maintenance during the period, caused considerable reduction in coal-fired power generation and thus dragged down the overall generating capacity in the first quarter.

The respective total power generation and total electricity sold of the Group’s main generating units for the three months ended 31 March 2015 are as follows:

Notes:

- (1) For Wan Mi Po hydropower plant, its electricity sold for the first quarter of 2015 was higher than that of its power generation because of some electricity sales rewarded by the grid corporation during the period.
- (2) The six new hydropower generating units of Tuokou of total installed capacity of 830MW commenced commercial operation during March 2014.

- (3) For Tumuxi hydropower plant, its power generation for the first quarter of 2015 recorded a significant increase was because of its sufficient reservoir storage at the end of last year which made possible the release of abundant water flow for power generation during the period.
- (4) The twenty-five new wind power generating units of Yaoposhan of total installed capacity of 50MW commenced commercial operation during November to December 2014 and February 2015 respectively.
- (5) The thirty-three new wind power generating units of Shanshan of total installed capacity of 49.5MW commenced commercial operation during March 2015.
