Power Generation and Electricity Sold for the First Three Quarters of 2016

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the nine months ended 30 September 2016, the combined total power generation of the Company and its subsidiaries (collectively, the “Group”) amounted to 50,770,289MWh, representing an increase of 7.40% over the same period last year while its combined total electricity sold amounted to 48,731,769MWh, representing an increase of 7.11% over the same period last year.

During the first three quarters of 2016, the hydropower generation of the Group continued to maintain its market advantage. The large capacity coal-fired power generating units, the newly operating wind power plant and photovoltaic power stations also drove the increase in the total power generation and electricity sold during the period as compared with the corresponding period last year.

The respective total power generation and total electricity sold of the Group’s main power generating units for the nine months ended 30 September 2016 are as follows:

Notes:

- (1) The second 1,000MW new coal-fired power generating units of Pingwei III commenced commercial operation in September 2015.
- (2) Yaomeng, was formerly named as Yaomeng II.
- (3) The hydropower generation in Sichuan Province continued to squeeze the space for coal-fired power generation of Fuxi in that region, resulted in the significant decline in power generation for the first three quarters of 2016.
- (4) For Wan Mi Po hydropower plant, its electricity sold for the first three quarters of 2016 was higher than that of its power generation because of some electricity sales rewarded by the grid corporation during the period.
- (5) Sichuan Jiu Yuan was affected by the severe flooding in the third quarter of last year and suspended its generating units for maintenance during that period. The power generation recorded a larger increase for the first three quarters of 2016 because of a comparative lower base.
