Electricity Sold for the First Half of 2017

China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, for the six months ended 30 June 2017, the combined total electricity sold of the Company and its subsidiaries (collectively, the “Group”) amounted to 29,639,547MWh, representing a decrease of 8.94% over the same period last year.

The fall in electricity sold in the first half of 2017 as compared to the corresponding period last year, mainly due to (1) the consistently low rainfall during the period along the river basins where the Group’s hydropower plants are located, resulting in a decline in power generation, and (2) the Group’s certain coal-fired power generating units suspended for overhaul maintenance in the second quarter caused a considerable reduction in power generation of individual coal-fired power plants. However, the production contributions from the new wind power plants and photovoltaic power stations narrowed the decrease in the overall electricity sales in the first half of the year.
