Electricity Sold for the Year 2017

China Power International Development Limited (the "Company") announces that based on the Company's preliminary statistics, the combined total electricity sold of the Company and its subsidiaries (collectively, the "Group") for the year ended 31 December 2017 amounted to 64,053,714MWh, representing an increase of 5.42% year on year.

The increase in accumulated electricity sold for the year 2017 as compared to the year 2016 was mainly due to (1) some individual coal-fired power plants recorded a considerable increase in power generation in the second half of the year after completing overhaul maintenance and resumed operation, (2) the abundant rainfall in the second half of the year drove up the hydropower generation and thus considerably narrowed the decrease in the annual electricity sales of hydropower as compared to the first half of the year; and (3) the newly operating wind power plants and photovoltaic power stations also contributed to the increase in the total electricity sold for the year.
