China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold of the Company and its subsidiaries (collectively, the “Group”) for the six months ended 30 June 2019 amounted to 42,261,760MWh, representing an increase of 27.70% compared to the same period last year.
