China Power International Development Limited (the “Company”) announces that based on the Company’s preliminary statistics, the combined total electricity sold by the Company and its subsidiaries (collectively, the “Group”) for the nine months ended 30 September 2022 amounted to 82,190,627MWh, representing an increase of 8.51% compared to the same period last year.
