(a) to approve, ratify and confirm the conditional placing agreement dated 11th December, 2007 (the "Placing Agreement") entered into between the Company and the Placing Agent pursuant to which, inter alia, the Company agrees to place, through the Placing Agent, on a fully underwritten basis, in aggregate 1,400,000,000 new shares at a price of HK\$0.12 per share; (b) to approve the allotment and issue of the shares of the Company pursuant to and in accordance with the terms and conditions of the Placing Agreement; and (c) to authorize any one director of the Company to exercise all powers to effect the placing of shares and the Placing Agreement.

To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a notarially certified copy of such power of attorney or authority, must be deposited at the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at Rooms 1806-7, 18th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, not less than 48 hours before the time appointed for holding of the Meeting or any adjourned meeting.

Where there are joint holders of any share of the Company, any one of such persons may vote at the Meeting, either personally or by proxy, in respect of such share as if he/she were solely entitled thereto, but if more than one of such joint holders are present at the Meeting personally or by proxy, that one of the said persons so presents whose name stands first on the register of members of the Company in respect of such share shall alone be entitled to vote in respect thereof.
