NOTICE OF ANNUAL GENERAL MEETING**

1. INTRODUCTION

The purpose of this circular is to notify shareholders of the Company the convening of the Annual General Meeting and to provide you with information in connection with the proposals: (i) to grant the general mandates to repurchase shares and to issue new shares of the Company; and (ii) to re-elect Directors.

2. GENERAL MANDATE TO REPURCHASE SHARES

At the annual general meeting of the Company held on 31st May, 2007, a general mandate was given by the Company to the Directors to exercise the powers of the Company to repurchase Shares of the Company. Such mandate will lapse at the conclusion of the

forthcoming Annual General Meeting to be held on 30th May, 2008. The Directors will propose the Repurchase Resolution at the Annual General Meeting to give a general mandate to the Directors to exercise all powers of the Company to repurchase on the Stock Exchange up to 10% of the issued share capital of the Company as at the date of passing the Repurchase Resolution. An explanatory statement as required under the Share Repurchase Rules to provide the requisite information of the Repurchase Proposal is set out in Appendix I hereto.

3. GENERAL MANDATE TO ISSUE SHARES

There will also be proposed at the Annual General Meeting two ordinary resolutions respectively granting to the Directors a general mandate to allot, issue and deal with Shares not exceeding 20% of the issued share capital of the Company as at the date of passing the resolution and adding to such general mandate so granted to the Directors of the Shares repurchased by the Company after the granting of the general mandate to repurchase up to 10% of the issued share capital of the Company as at the date of passing the Repurchase Resolution. Based on 1,792,030,669 Shares in issue as at the Latest Practicable Date and assuming that no shares are issued or repurchased by the Company prior to the Annual General Meeting, 20% of the issued share capital of the Company will be 358,406,134 Shares.

4. RE-ELECTION OF DIRECTORS

In accordance with Article 116 of the Articles of Association, Mr. Wang Shao Lan, Mr. Shang Jianguang and Mr. Lam Toi Man will retire by rotation at the Annual General Meeting and, being eligible, offer themselves for re-election. Details of the Directors who are proposed to be re-elected at the Annual General Meeting are set out in Appendix II hereto.

5. ANNUAL GENERAL MEETING

On pages 10 to 13 of this circular, you will find a notice convening the Annual General Meeting which contains, inter alia, the proposed resolution to re-elect directors and the following proposed resolutions:

- an ordinary resolution to grant to the Directors a general mandate to exercise all powers of the Company to repurchase on the Stock Exchange Shares representing up to a maximum of 10% of the issued share capital of the Company as at the date of passing the Repurchase Resolution;
- an ordinary resolution to grant to the Directors a general mandate to authorise the Directors to issue, allot and deal with Shares not exceeding 20% of the issued share capital of the Company as at the date of passing such resolution; and
- an ordinary resolution to extend the general mandate which will be granted to the Directors to issue, allot and deal with additional Shares by adding to it the number of Shares repurchased under the Repurchase Proposal after the granting of the general mandate.

At the Annual General Meeting, a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is required to be taken under the Listing Rules or unless a poll is (before or on the declaration of the result of the show of hands) demanded (a) by the chairman; or (b) by at least three members present in person or by proxy for the time being entitled to vote at the meeting; or (c) by any member or members present in person or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or (d) by any member or members present in person or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of all the shares conferring that right.

On a show of hands, every member who (being an individual) is present in person or (being a corporation) is present by a duly authorised representative shall have one vote, and on a poll every member present in person or by proxy shall have one vote for every fully-paid share of which he is the holder. On a poll, a member entitled to more than one vote need not use all his votes or cast all the votes he uses in the same way.

6. ACTION TO BE TAKEN

A form of proxy for use at the Annual General Meeting is enclosed herein. Whether or not you intend to attend the Annual General Meeting, you are requested to complete the form of proxy and return it to the principal place of business of the Company at Units 1902-04, Level 19, International Commerce Centre, 1 Austin Road West, Kowloon, Hong Kong not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and return of the form of proxy shall not preclude shareholders of the Company from attending and voting in person at the Annual General Meeting if they so wish.

7. RECOMMENDATION

The Directors believe that the proposed resolution to re-elect directors, the Repurchase Proposal and the general mandate for Directors to issue new Shares to be put forward at the Annual General Meeting are all in the best interests of the Company and its shareholders. Accordingly, the Directors recommend that all shareholders of the Company should vote in favour of such resolutions to be proposed at the Annual General Meeting.

This appendix serves as an explanatory statement, as required by the Share Repurchase Rules, to provide requisite information to you for your consideration of the proposal to permit the repurchase of Shares up to a maximum of 10% of the issued share capital of the Company as at the date of passing the Repurchase Resolution.

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,792,030,669 Shares.

Subject to the passing of the Repurchase Resolution and on the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Company would be allowed under the Repurchase Resolution to repurchase a maximum of 179,203,066 Shares (representing 10% of the issued share capital of the Company as at the date of passing the Repurchase Resolution).

2. REASONS FOR REPURCHASE

The Directors believe that the Repurchase Proposal is in the best interests of the Company and its shareholders. Such repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets and/or earnings per Share of the Company and will only be made when the Directors believe that such a repurchase will benefit the Company and its shareholders.

3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum and articles of association and the Companies Law. The Companies Law provides that the amount of capital repaid in connection with a share repurchase may be paid out of the profits of the Company or the proceeds of a fresh issue of shares made for the purposes of the repurchase or in the manner provided for in section 37(5) of the Companies Law. The amount of premium payable on repurchase may only be paid out of either the profits of the Company or out of the share premium account before or at the time the Company's shares are repurchased or in the manner provided for in section 37(5) of the Companies Law.

There might be an adverse impact on the working capital or gearing position of the Company as compared with the position disclosed in the audited accounts contained in the annual report for the year ended 31st December, 2007 in the event that the power to repurchase Shares pursuant to the Repurchase Proposal is to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the power to repurchase Shares pursuant to the Repurchase Proposal to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

5. UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the powers of the Company to make repurchases pursuant to the Repurchase Resolution and in accordance with the Listing Rules and the applicable laws of the Cayman Islands.

None of the Directors nor, to the best of their knowledge and belief and having made all reasonable enquiries, their associates, have any present intention to sell any Shares to the Company or its subsidiaries under the Repurchase Resolution if such is approved by the shareholders of the Company.

No connected persons (as defined in the Listing Rules) have notified the Company that they have a present intention to sell Shares to the Company or its subsidiaries, or have undertaken not to do so, in the event that the Repurchase Proposal is approved by the shareholders of the Company.

6. TAKEOVERS CODE

If on the exercise of the power to repurchase Shares pursuant to the Repurchase Proposal, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of Rule 32 of the Takeovers Code. As a result, a shareholder or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rules 26 and 32 of the Takeovers Code.

As at the Latest Practicable Date, the register maintained by the Company pursuant to section 336 of Part XV of the Securities and Futures Ordinance shows the following interests in Shares being 5% or more of the issued share capital of the Company:

Note: Mr. Hon Kwok Lung holds 80% and his wife, Ms. Lam Suk Ying holds 20% interests in Sincere View International Limited ("Sincere View") which is the controlling shareholder of the Company holding 683,441,515 shares of the Company.

Mr. Hon Kwok Lung and Ms. Lam Suk Ying are deemed to have an interest in the same parcel of shares of 683,441,515 held by Sincere View.

Based on the above shareholding and in the event the Directors exercised in full the power to repurchase Shares pursuant to the Repurchase Proposal, an obligation to make a general offer to shareholders under Rules 26 and 32 of the Takeovers Code may arise. The Directors have no present intention to exercise the power to repurchase Shares pursuant to the Repurchase Proposal to such extent as would result in takeover obligations. In the event that the Repurchase Proposal is exercised in full, the number of Shares held by the public would not fall below 25%.

7. SHARES REPURCHASE MADE BY THE COMPANY

The Company had not repurchased any Share (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

Mr. Wang Shaolan

Mr. Wang, aged 45, had been appointed as the Executive Director and Chief Executive Officer of the Company on 9th June, 2000. He ceased to act as the Chief Executive Officer and assumed the role of Vice Chairman of the Company since 5th July, 2004. Mr. Wang holds a Bachelor degree in Engineering from Tsinghua University, PRC and a Master degree in Economics from Peking University, PRC. Mr. Wang was formerly General Manager of China Township Enterprise Investment & Development Company Limited.

Mr. Wang has entered into a service agreement with the Company for a term of 1 year commencing from 5th July, 2007. Under the terms of the service agreement, Mr. Wang is entitled to a monthly salary of HK\$112,350 payable on a 13-month basis and a bonus payable within one month after the financial year end of the Company to be determined by the Board by reference to the results in respect of that financial year of the Company. The basic salary was determined with reference to the remuneration benchmark in the industry and the prevailing market conditions. Mr. Wang does not have any relationship with any directors, senior management or substantial shareholder or controlling shareholder of the Company and does not have any interests in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as disclosed above, Mr. Wang neither have any positions held with the Company and other members of the Company's group nor have other directorships held in listed public companies in the last three years and other major appointments and qualifications. Pursuant to the section 13.51(2) of the Listing Rules, there are no other matters with respect to the above that need to be brought to the attention of the shareholders of the Company.

Mr. Shang Jianguang

Mr. Shang, aged 56, has been appointed as an Executive Director and Chief Executive Officer of the Company since 18th November, 2004. He was graduated in Fuzhou University, PRC majoring in Chemistry and is a qualified senior engineer in Mainland China. In November 1999, he was appointed as Deputy General Manager of Min Xin Holdings Limited, (stock code of 222) a company listed on the main board of the Stock Exchange, and he was subsequently appointed as General Manager and director in April 2001 and November 2002 respectively. In October 2004, Mr. Shang resigned as General Manager and resigned as a director in November 2004.

Mr. Shang has entered into a service agreement with the Company for a term of 2 years commencing from 18th November, 2006. Under the terms of the service agreement, Mr. Shang is entitled to a monthly salary of HK\$100,000, monthly housing allowance of HK\$35,000, a year-end double pay equivalent to one-month's basic salary and a discretionary bonus as may be decided by the Board with reference to the Company's performance and profitability. The basic salary was determined with reference to the remuneration benchmark in the industry and the prevailing market conditions. Mr. Shang

does not have any relationship with any directors, senior management or substantial or controlling shareholders of the Company and does not have any interests in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as disclosed above, Mr. Shang neither have any positions held with the Company and other members of the Company's group nor have other directorships held in listed public companies in the last three years and other major appointments and qualifications. Pursuant to the Section 13.51(2) of the Listing Rules, there are no other matters with respect to the above that need to be brought to the attention of the shareholders of the Company.

Mr. Lam Toi Man

Mr. Lam, aged 50, has been appointed as an Executive Director of the Company since 8th April, 2004. He has various years of experience in property development in the PRC. Mr. Lam has been the General Manager of Zhejiang Huashun Real Estate Investment Co., Ltd. In addition, he has been appointed as an executive director and the General Manager of Hangzhou Yuanhua Mart Construction Co., Ltd. Mr. Lam is the brother-in-law of Mr. Hon Kwok Lung, Chairman of the Board. In addition, the husband of Ms. Sit Lai Hei, a Non-executive Director, is a nephew of Mr. Lam.

Mr. Lam has entered into a service agreement with the Company for an initial term of 2 years commencing from 1st July, 2004 and is subject to termination by either party by giving not less than two months' written notice. The service agreement will continue for successive terms of one year unless terminated by not less than two months' written notice served by either party to the other. Under the terms of the service agreement, Mr. Lam is entitled to a monthly salary of HK\$110,000 payable on a 12-month basis and a discretionary bonus payable for each completed year of service to be decided by the Board with reference to the Company's performance and profitability. The basic salary was determined with reference to the remuneration benchmark in the industry and the prevailing market conditions. Save as disclosed herein, Mr. Lam does not have any relationship with any directors, senior management or substantial shareholder or controlling shareholder of the Company and does not have any interests in the shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance.

Save as disclosed above, Mr. Lam neither have any positions held with the Company and other members of the Company's group nor have other directorships held in listed public companies in the last three years and other major appointments and qualifications. Pursuant to the section 13.51(2) of the Listing Rules, there are no other matters with respect to the above that need to be brought to the attention of the shareholders of the Company.
