However, due to the legal restrictions under the Prevention and Control of Disease (Requirements and Directions) (Business and Premises) Regulation (Cap. 599F of the Laws of Hong Kong) and the Prevention and Control of Disease (Prohibition on Gathering) Regulation (Cap. 599G of the Laws of Hong Kong) which limit the number of people permitted for group gatherings in force at the time of preparing this proxy form, the Meeting will be held with the physical attendance of a minimum number of persons, comprising Directors and/or other senior staff members who are Shareholders or proxies, to ensure compliance with quorum requirements under the Articles of Association of the Company as well as gathering restrictions and social distancing laws and regulations.
