(I) The Capital Reorganisation, which was effective on 3 December 2010, comprised the Capital Reduction, Share Sub-division and the Share Consolidation.

Pursuant to the Capital Reduction, the par value of each issued Existing Share was reduced from HK\$0.10 to HK\$0.001 by the cancellation of HK\$0.099 of the paid-up capital on each issued Existing Share.

Pursuant to the Share Sub-division, each authorised but unissued Existing Share with a par value of HK\$0.10 each was sub-divided into 100 Shares with a par value of HK\$0.001 each.

Pursuant to the Share Consolidation, every 10 issued and unissued Shares with a par value of HK\$0.001 each were consolidated into one New Share of HK\$0.01 each.

(II) 909,785,366 Subscription Shares of par value HK\$0.01 each (at the Subscription Price of approximately HK\$0.0879 per Subscription Share) and 52,894,498 Remuneration Shares of par value HK\$0.01 each (at a price of approximately HK\$0.0879 per Remuneration Share) were issued on 3 December 2010.
