The Board announces that all the conditions of the Placing have been fulfilled and the completion of the Placing took place on 29 October 2014. 330,399,800 Placing Shares have been successfully placed by the Placing Agent to not less than six independent Placees at the Placing Price of HK\$0.70 per Placing Share pursuant to the terms and conditions of the Placing Agreement.

Reference is made to the announcement of Crown International Corporation Limited (the “**Company**”) dated 22 October 2014 in respect of the Placing (the “**Announcement**”). Unless defined otherwise, capitalized terms used herein shall have the same meanings as those defined in the Announcement.

## **COMPLETION OF THE PLACING**

The Board announces that all the conditions of the Placing have been fulfilled and the completion of the Placing took place on 29 October 2014. 330,399,800 Placing Shares have been successfully placed by the Placing Agent to not less than six independent Placees at the Placing Price of HK\$0.70 per Placing Share pursuant to the terms and conditions of the Placing Agreement.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, the Placees and their ultimate beneficial owners are Independent Third Parties. None of the Placees has become a substantial Shareholder (as defined under the Listing Rules) immediately after the Placing. The net proceeds of the Placing, after deduction of expenses are approximately HK\$230,281,358, which is intended to use for general working capital of the Group.

## **EFFECTS ON SHAREHOLDING STRUCTURE**

The 330,399,800 Placing Shares represent approximately (i) 18.06% of the issued share capital of the Company immediately before completion of the Placing; and (ii) 15.30% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares.
